



# Building Control

## Guidance Leaflet

### *Competent Person Schemes*

This leaflet is one of a series produced by the Hertfordshire Building Control Technical Forum

#### **What is a Competent Person Scheme?**

When you carry out certain types of building work, you are required to ensure that the work is carried out in accordance with the Building Regulations 2010. This would require that you submit an application to your Local Authority Building Control Department for assessment of your project and inspection of the works on site.

However as an alternative and to provide householder's with more choice, the Government has created Competent Person Schemes for certain trades. An individual or company registered under a Competent Person Scheme is able to self-certify that their work is in compliance with the Building Regulations 2010.

#### **Who can be part of a Competent Person Scheme?**

If a company or individual wishes to join a Competent Person Scheme for their particular profession, they will need to meet the specific requirements set out by each Scheme. Whilst the conditions of membership will differ between Schemes, these are usually based on the qualifications held by the individual to demonstrate competency in their trade.

#### **What works are covered by the Competent Person Scheme?**

There are a variety of Competent Person Schemes (CPS) available covering a range of different building works, usually minor works involving the replacement of building services and fittings. Listed below are the main Competent Person Schemes available and the criteria required to be met in order for a Competent Person to be employed.

##### **Installation of a Gas Appliance\***

Appliance has a rated heat output of up to 100 kilowatts and is installed in a dwelling or other building of no more than 3 storeys (excluding basement) – CPS:

*\*Note: It is mandatory that the installation of any gas appliance is carried out by a member of the 'Gas Safe Register'.*

##### **Installation of an Oil Appliance**

Appliance has a rated heat output of up to 100 kilowatts and is installed within a dwelling or other building of no more than 3 storeys (excluding basement). An oil storage tank connected to appliance is included – CPS:

### **Installation of Solid Fuel Appliances**

Appliance has a rated heat output of up to 50 kilowatts and is installed within a dwelling or other building of no more than 3 storeys (excluding basement) – CPS:

### **Replacement Windows and Doors**

Replacement windows, doors and rooflights in an existing dwelling - CPS

### **Domestic Electrical Installation**

Applicable to new circuits, new/replacement consumer units and any electrical works carried out in a kitchen, bathroom or outside – CPS:

### **Installation of new sanitary and washing facilities**

Installation of new or replacement sanitary appliances within bathroom, WC or utility room which does not affect the underground drainage system - CPS

### **Ventilation and Air Conditioning**

Installation of new mechanical air conditioning systems - CPS

Plumbing and water supply systems – CPS:

### **Do I have to use the Competent Person Scheme?**

With the exception of Gas Safe, Competent Persons Schemes are not mandatory. They have been provided to give the householder different options of how to ensure compliance with the Building Regulations 2010.

***The above list of Competent Persons Schemes may not be exhaustive and other individuals and corporations may have obtained registration under the Competent Person Scheme.***
